#### How to submit the entries?

All entries must be handed to the class teacher or to our Customer Service team (1st floor in Rose Hill Monday – Saturday or Reception at Northfields International School on Saturdays only).

Please note all entries must include:

- ✓ the original artwork
- ✓ the completed and signed Parental Permission form and Image Release form (see overleaf)
- ✓ the participant's name, age and title of the work

## When will the local winners and finalists be announced?

Local finalists will be chosen for each age category. One local winner in each age category will be announced in early September 2023 and will be submitted to the global competition. All local finalists and winners will receive a prize.

## What happens at the global competition level?

The global competition will be judged during September 2023 and 12 pictures will be selected to be displayed in promotional materials relating to the British Council's work in English and Exams.
